# Health Requirements for Entering Glenbard West High School

#### **High school transfer students from Illinois:**

- 1. Copy of your 9<sup>th</sup> Grade DHS Physical from your former school.
- 2. **Immunization Records** Completed on the 9<sup>th</sup> Grade Physical Form. if vaccines are needed an appointment card from Medical Provider for completion within 30 days of first day attendance must be presented before student will be allowed to attend. **See back page for Vaccine Requirements.**
- **3. Dental Exam** if transferring as a freshman.

### Transfer Student from out of state, or out of the country entering an Illinois school for the first time:

- 1. **Physical Exam** on an Illinois Department of Health Services (DHS) form. The exam must be completed within one year prior to the date of entry.
- 2. **Immunization Records** Completed and signed by medical provider on the Physical Form. If vaccines are needed an appointment card from Medical Provider for completion within 30 days of first day attendance must be presented before student will be allowed to attend. **See back page for Vaccine Requirements.**
- 3. **Eye exams** (by an ophthalmologist or optometrist) are required for students entering an Illinois school for the first time.
- 4. **Dental Exam** if transferring as a freshman.

#### If you are a student returning to Illinois:

- 1. **Copy of your 9<sup>th</sup> grade DHS Physical Exam.** Exam must have been completed within one year prior to date of 9<sup>th</sup> grade entry to an Illinois school.
- 2. **Immunization Records** Completed on the 9<sup>th</sup> Grade Physical Form. If vaccines are needed an appointment card from Medical Provider for completion within 30 days of first day attendance must be presented before student will be allowed to attend. **See back page for Vaccine Requirements.**
- **4. Dental Exam** if transferring as a freshman.

## Students may not attend school until Health Requirements are met.

#### **Required Vaccines**

- -**Tdap:** Proof of one dose is required.
- -**Tetanus**: Proof of two or more doses of DTP/DTaP or Td.
- **-Varicella** (chicken pox): Proof of two doses required with first dose on or after 1<sup>st</sup> birthday, or proof of Immunity (Physician statement or laboratory evidence submitted with immunization records).
- **-MMR** (Measles, Mumps and Rubella): Proof of two doses with first dose on or after 1<sup>st</sup> birthday (Physician statement or laboratory evidence submitted with immunization records).
- -**Polio**: Proof of three or more doses with last dose received on or after 4<sup>th</sup> birthday.
- -Hepatitis B: Proof of three (3) shot series.
- -Meningococcal: One dose required for students entering 9th, 10th grade and 11th grade. Proof of two doses for students entering 12th grade (if the first dose was given on or after the 16th birthday, only one dose is required).

Health Forms: <u>www.glenbardwesths.org</u> Highlight Parents, Click on forms under Health Services. Action Plans and Med orders for asthma, allergies, seizure, diabetes, and/or other health needs must be updated every year.

Keep a copy of student physical/vaccines for your records at home.

Students may not attend school until Health Requirements are met.
